III. Tax-Exempt Bond

a) Ms. Mackley and Messrs. Bruno, and Mauritsen presented the resolution for Virginia Baptist Homes Inc d/b/a LifeSpire of Virginia in Botetourt to authorize refunding \$38,000,000 of 501(c)3 Tax-Exempt Bonds.

V. <u>Tax-Exempt Bond</u>

a) Mses. Mackley, Nichols, and Mr. White presented the resolution for Hampton University to authorize \$85,000,000 in 501(c)3 Tax-Exempt Bonds to refund the balance of a 2014 bond issuance.

VII. Economic Development Loan Fund

a) Ms. Tackett and Mr. Perry presented the Industrial Development Authority of Danville's resolution to authorize Economic Development Loan Fund of \$2,981,534
